Contributors Program - Young Voices' premier project provides pro bono op-ed editing and media placement services to talented writers under 30 knowledgeable in the classical liberal tradition. Our fiscal year 2019 was the most successful to date for the program, successfully placing 453 articles and 223 broadcast interview hits (e.g. radio, TV, podcast, etc.) in noted outlets including CNN, Fox News, and USA Today.

4b (Code:) (Expenses \$ 14,100 including grants of \$ 14,100) (Revenue \$)
Policy Fellowships - In 2017, Young Voices launched a new program giving a select cohort of our contributors the opportunity to take a deep-dive on specific policy issue areas. This year, we successfully completed two such policy fellowships on the issues of preserving democracy (Free Society Fellowship) and encouraging innovation (Tech Policy Fellowship). Ten fellows were paired up with think tank mentors with the expectation of producing tailored media hits (i.e. op-eds, TV, radio, podcasts) communicating the importance of preserving free markets and individual rights.

Young Voices Awards - In 2018, Young Voices teamed up with the Reason Foundation to give away an award recognizing excellence in pro-liberty advocacy to one writer under 30. The first Young Voices Award was given to Contributor Nolan Gray at the 2018 Reason Media Awards at FreedomFest in Las Vegas on July 14, 2018. The second Young Voices Award was given away to Contributor Molly Davis at Young Voices' Third Anniversary Party on May 2, 2019. Young Voices plans to make this award a tradition for years to come.
