Our fiscal year 2020 was the most successful to date for the program, successfully placing 454 articles and 229 broadcast interview hits (e.g. radio, TV, podcast, etc.) in noted outlets including Fox News, USA Today, and the Wall Street Journal.

4b (Code: ) (Expenses \$ 60,000. including grants of \$ 29,403. ) (Revenue \$ ) Policy Fellowships: Young Voices offers an opportunity for select writers in our program to take a deep-dive on specific policy issue areas. This year, we successfully completed four such policy fellowships on the issue areas of technology, foreign policy, education, and consumer freedom. 12 fellows were paired up with think tank mentors with the expectation of producing tailored media hits (i.e. op-eds, TV, radio, podcasts) communicating the importance of preserving free markets and individual rights.
